fixed the problem temporarily using blue tape (and found that 4 layers is equal to 1/64"!) but was wondering how to adjust it without such a shim. There was not a conclusive solution. [Gary adds: Chuck came over with his router and we tried it again: there was no offset, so it appears to be an issue with

his router. Four layers of blue tape is much cheaper than a new router so that's my best solution at this point.]

the four-pillar jewelry box he just finished for his wife's shawl pin collection. It is made of maple with cocobolo drawer pulls, and figured maple drawer fronts made from shop-sawn veneers.

This was his original design inspired by the planter boxes he made a few months ago.

Marc Collins announced that he is selling his Rigid shop vacuum with an Onida Dust Deputy and hose, for \$120.

Marc also showed pictures of the raised garden beds he built in his back yard. They were made from redwood and feature a rabbeted ledge to sit on and pockets to hold the legs for the sunshade canopies. He finished it with raw linseed oil and installed a grid irrigation system.

people I would have wanted on my jury if I needed a jury to mete out justice. After jury selection questioning, I was chosen to be juror number eleven. I sat through 4 days of testimony for both sides, and a day of attorney summation.

During the trial I was fascinated by the interaction between the lawyers as they helped each other set up white boards or share an overhead slide even though they were adversaries. There was also a large difference between the way the lawyers presented their cases. One attorney used technology to show video clips of depositions and displayed evidence on a video screen. In contrast the other attorney stuck to live testimony and printed pages on an overhead projector.

One of the most difficult things about being a juror was that we were instructed not to speak about the case to anyone, not even other jurors. When we finally got into the jury room to deliberate, it felt good to know that the other 11 members also felt the frustration that I did. We all had a good chuckle over it. Then the hard work began.

We needed to come up with a judgement on negligence and put a dollar amount on what it caused. This was not easy because as you would expect the lawyers had given us widely divergent amounts that they felt was in their clients’ best interest. We jurors reached a decision that put forward a method for a fair alternate settlement, thus ending our time on Jury Duty.

Jury Duty is not an easy thing to do, because it takes time and intense concentration. It takes a group to accomplish the work and feels good when you have completed it. Much like our toy builds, Jury Duty is another way to give back to our community.

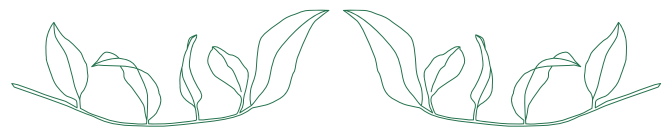

Ed Sheanin showed the piggy banks, which are made of three layers of 3/4" lumber. The pattern will be posted on our website. He also showed sports cars, shaped from 5 layers of laminated 3/4" lumber, which are then band-sawn and sanded smooth. Finally, Ed reviewed the chess/checker boards.

Jim Kelly showed the treasure chests, including the process and jigs to cut the slats at the necessary angles.

Jeff Bremer presented the teen boxes, treasure chests and race cars.

Marc Collins described the evolution of the block trucks. He noted that he uses purpleheart for the routing patterns because it is hard and is more resistant to long-term wear from router bearings, as hundreds of parts are made from each pattern.
